# Appraisal License State Requirements: Oklahoma

Post-2008 Appraiser's License National Requirements

The information contained in below is designed to provide a summary of the minimum education, experience and examination requirements established by the Oklahoma Real Estate Appraiser Board.

Levels of Licensure

There are four levels of real estate appraiser licensing. They are:

Appraiser Trainee License State Licensed Appraiser License Certified Residential Appraiser License Certified General Appraiser License

To be Eligible for Licensure, a person must:

Complete the required educational hours
Satisfy the experience requirements
Submit the appraisal application to the Board for approval and processing
Pass the State examination (exam fee is \$150)
Pay the Federal Reistry Fee of \$25.00 annually (not necessary for Trainee level).
Pay the license/certification fee (\$150.00 for Trainee, \$175.00 for License/Certification).

#### Education:

Each level must successfully complete the specified hours of approved real estate appraisal courses for each level of licensure, which includes at least 15 hours on the Uniform Standards of Professional Appraisal Practice (USPAP). The specified hours are:

75 hours for the Appraiser Trainee classification

90 hours for the Licensed Appraiser classification. The classroom hours required for the licensed real estate appraiser may include the classroom hours required for the appraiser trainee.

120 hours for the Certified Residential Appraiser classification. The classroom hours required for the certified residential real estate appraiser may include the classroom hours required for the appraiser trainee or the licensed real estate appraiser.

180 hours for the Certified General Appraiser classification. The classroom hours required for the certified general real estate appraiser may include the classroom hours required for the appraiser trainee, the licensed residential real estate appraiser, or the certified residential real estate appraiser.

### Experience:

All experience must be supported by documentation on forms provided by the Board.

There is no experience requirement for the Appraiser Trainee. Appraiser Trainee's experience must be under the direct supervision of a Licensed/Certified Appraiser.

Applicants for a State Licensed Appraiser license shall have obtained 2,000 hours preceding the application to the Board.

Applicants for a Certified Residential Appraiser license shall have a minimum of 2,500 of experience obtained during no

Applicants for a Certified General Appraiser license shall have a minimum of 3,000 hours over a 30 month period. Of these hours, 1,500 must be in non-residential properties.

# License Renewal:

License expire every three years from the date printed on the license.

# Continuing Education Requirements:

When renewing license/certificates, Appraisers must submit proof of 42 hours of continuing education credit taken within the three years of licensing/certification.
